



Secure Technology Alliance FAQs

What is the Secure Technology Alliance?

The Secure Technology Alliance is the digital security industry's premier association, focusing on the U.S. market. The Alliance brings together industry providers and adopters to drive the adoption of end-to-end security solutions designed to protect privacy and digital assets in a variety of vertical markets. Members drive the mission of the Alliance through many activities including industry and technology councils, focused events, educational resources, communications, industry outreach and advocacy and training and certification programs.

What is the mission of the Alliance?

The Alliance's mission is to stimulate understanding, adoption and widespread application of connected digital solutions based on secure chip and other technologies and systems needed to protect data, enable secure authentication and facilitate commerce.

How does the Alliance define the digital security industry?

The digital security industry is comprised of the organizations involved in developing and implementing the technologies and systems needed to secure our identities, assets and transactions in the increasingly online and mobile world.

Does the Alliance still promote the adoption and usage of smart card technology?

Yes, the Alliance views smart card technology (also referred to as secure chip technology) as a foundational security technology for securing digital assets, protecting identities and privacy and preventing fraud. The Alliance also promotes additional emerging technologies and systems that can help organizations meet these security goals.

What security technologies does the Alliance represent?

The Alliance supports exploration and education on security technologies that protect data, enable secure authentication and facilitate commerce. This includes secure chip as well as other technologies and systems, such as cryptography, tokenization, blockchain and trusted execution environments (TEEs).

On which industries does the Alliance focus?

The Alliance is focused on promoting the adoption of secure digital solutions in payments, mobile, healthcare, identity and access and transportation. Additionally, the Alliance focuses on emerging markets such as the Internet of Things (IoT) which, while still young, has the power to change the way we live at home, work and in our travels and requires similar security solutions.

How does the Alliance influence security in new areas such as IoT?

The Secure Technology Alliance has been the committed voice in facilitating the adoption of secure solutions for over 15 years. The Alliance has been instrumental in driving the need for security to be built into every device, product and service throughout their lifecycle within payments, identity and access markets. Now, the Alliance sees similar security needs in new

areas, particularly IoT, and uses its proven processes to provide the technology providers and adopters with the insights they need to build security in at the point of development and implementation.

Why do companies join the Alliance?

Membership and participation in Alliance activities enables organizations of all sizes, and their respective individual members, in all industries to not only be at the forefront of digital security, but to help shape it by sharing expertise, debating with industry thought leaders and influencing industry best practices.

What are the benefits of joining the Alliance at the Leadership Council level versus the General membership?

Organizations receive several benefits for being part of the Leadership Council. Most importantly, Leadership Council members can set the direction and overall priorities of the entire organization by being elected as a voting member of the Alliance board. It also makes them eligible to serve as chair of one or multiple councils, which is ideal for larger organizations that want to make an impact and have diverse business interests (payments and access control, for example). Leadership Council organizations receive other event benefits, such as additional complimentary registrations above other membership levels.

Those Leadership Council members interested in also taking part in the U.S. Payments Forum can consider the Leadership Council PLUS, which provides full membership to both organizations.

What is the relationship between the Secure Technology Alliance and the U.S. Payments Forum?

The U.S. Payments Forum, formerly called the EMV Migration Forum from 2012 to 2016, was formed by the Smart Card Alliance (which changed its name to the Secure Technology Alliance in 2018), and continues to be an affiliated chapter of the Alliance. The Forum has its own separate bylaws and membership and is managed by a Forum-member-elected Steering Committee, with management oversight by the Secure Technology Alliance Board of Directors.

What are the benefits of participating in Alliance Councils?

The Alliance Councils are critical in providing the digital security industry with market intelligence, thought leadership and influence on standards and best practices. Participation is an exclusive benefit to members, who are able to collaborate with thought leaders and peers on the key issues affecting their industries. They can provide insights and get first access to an array of assets, including reports, white papers, workshops, webinars, infographics, statement documents and more.

How do Alliance events compare to similar events? How would I benefit as a member?

The Alliance holds several focused events throughout the year, which provide a deeper level of content than similar events. Alliance events zero-in on key industry issues, assessing strategies to determine the best practices and technologies for building security into every device throughout its lifecycle. Industry thought leaders provide attendees with insights into real-world approaches for developing and implementing end-to-end digital security solutions.

Members cite in-person networking with partners, sector innovators and customers as a major benefit of Alliance events.
