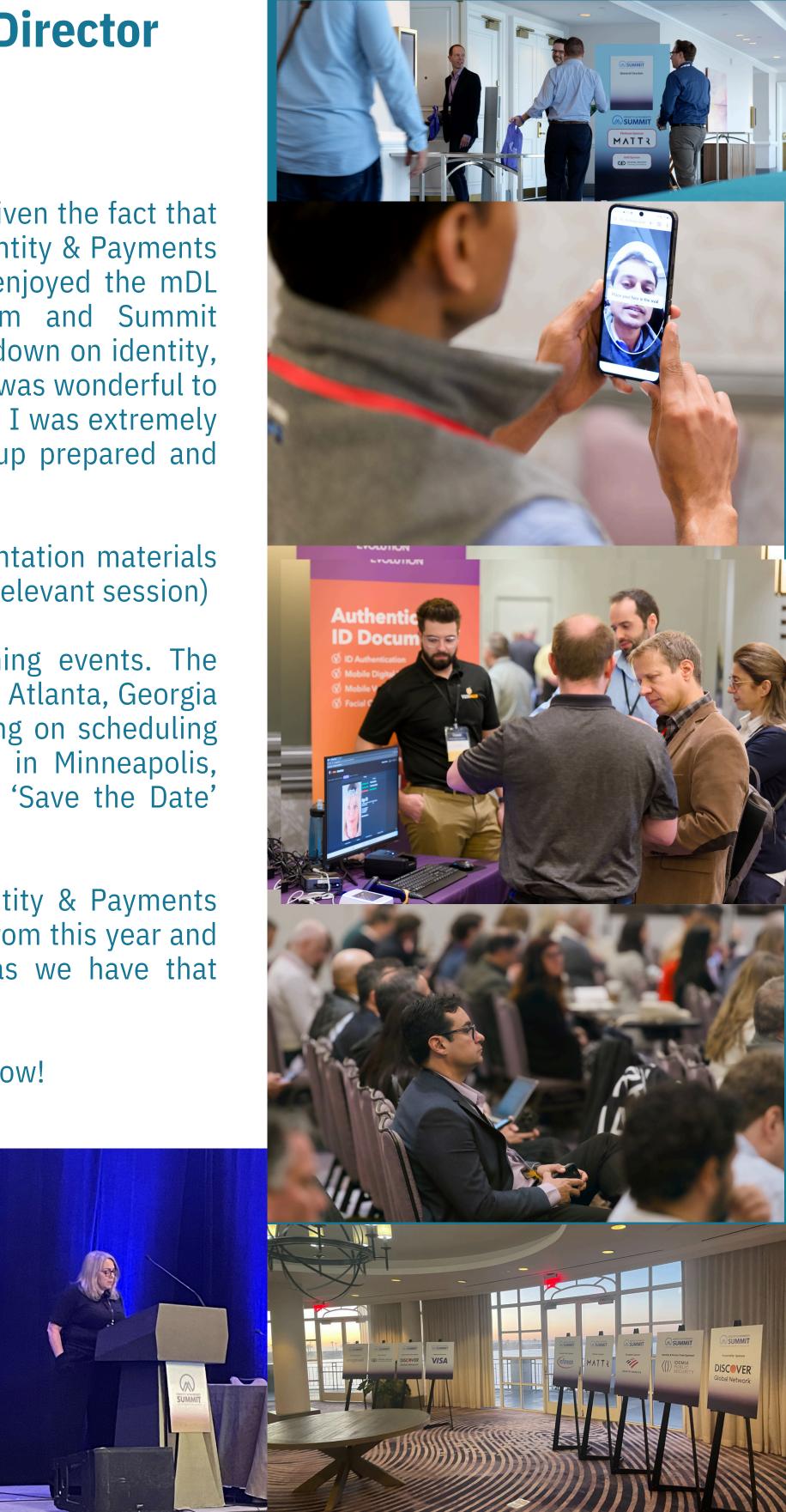
Message from our Executive Director
